Connecting with an Advisor

Applicants will be evaluated by the Admissions Committee for preliminary acceptance based on the program's academic admissions criteria. Candidates who pass this initial review will be requested to solicit a program advisor prior to final acceptance. The Admissions Committee will make initial recommendations for potential advisors among our regular faculty, courtesy faculty, and instructors. You can learn more about the expertise of <u>Fisheries and Wildlife faculty</u> and contact them directly to explore mutual interests. Often, courtesy faculty who are employees of state and federal agencies are good choices for PSMFWA advisors if their current duties allow time to work with you. It is up to you to contact potential advisors and secure a commitment from an advisor before admission.

When you contact prospective advisors, you will need to provide information about yourself, why you want to join the PSM program, and your preliminary goals and plan for your internship. See the attached template letter, and modify it as you like for specific faculty. A general timeline for your degree can help an advisor understand the time commitment involved. Some faculty are not very familiar with PSMFWA, so you may also want to provide a link to the program website.

Your faculty advisor will act as your major professor through your PSM program. He or she will review your planned coursework, approve your program of study, meet with you regularly (electronically), help you find committee members and schedule committee meetings, review your internship documents and project products, and help you prepare for your defense. Finally, your advisor will sign your defense paperwork when you complete the program.

The department's Online <u>Graduate Programs Coordinator</u>, will assist you with curriculum planning and making contact with potential advisors. She will also monitor students' progress and alert the advisor and the Distance Education Coordinator, <u>Bruce</u> <u>Dugger</u>, in the event of any problems with academic performance and progress.

A preliminary timeline should be included with your application materials. Once you are admitted to the program, you must also file a <u>Program of Study form</u> with the Graduate School prior to completion of your first 18 credits. The Graduate School will inform you of any deficiencies in your plan and notify you and the Online Programs Coordinator when it is approved. You may change your program of study at any time by filing an amended Program of Study form.
